


# AMICI DI RAOUL FOLLEREAU

# 3. Capacity building of NGO by DHWANI FOUNDATION: NIRANTHARA PROGRAMME



AMICI with two more partners ORBIT Bidar and MOB Mandya participating in the Niranthara Programme.

Dhwani Foundation is a Bangalore based NGO, backed by group of committed and dedicated team. The vision of Dhwani Foundation is to develop institutional capacity of NGOs. They have started Niranthara programme for strengthening NGOs. Niranthara program is designed towards building institutional capacities of NGOs through 18 Months intervention. The main objectives of the programme is to evolving strategy, improve good governance and sharpen NGO's message to outside the world to suit the current requirements of the NGO sector ,increase organizational capacity to meet the requirements of the transition of development sector, develop all compliances, policies; improve administrative systems and procedures for CSR requirements and the beneficiaries, improve organisational capacity in terms of both technical and financial, good governance and accountability with greater transparency. These training will cover mapping ecosystem and acting on change, Governance, Legal Compliances & HR Policies, Finance & Accounts Management, Management & Information Systems (MIS), Communication, Brand Building, Marketing & Fund Raising, Leadership Development and Project / Program Management.

# 4. Community Based Inclusive Development project: SAMRUDDI, HAROHALLI



The literary meaning of Samruddhi is "Aiming together for success / Prosperity / wealth". This project is called as "Samruddhi" since its multi sectoral and multi integral nature of community based inclusive development (CBID).

This project is a combination of three key components as given below:

- A) Community Based Inclusive development (CBID) focusing on empowering different groups of persons with disabilities including persons with disabilities due to leprosy.
- B) Primary health care with a specific concentration on promoting nutrition among children, girls, women and their health improvement.
- C) Use of technology specifically focusing on promoting community radio and IT advancement.

This project is directly managed by AMICI with the collaborative support from SRMAB, Hobli Rehabilitation Committee of Harohalli-HRC and other likeminded organizations.

The Samrudhi project covers six grama

Panchayaths namely: A) Harohalli.

B).Kagalahalli. C) Devasandra. D) Koliganahalli.

E). Kottagalu and F) Doddamudhavadi

Panchayaths. In these Six panchyaths, the project covers a total of 116 villages. There are 349 Shree Shakthi Self help groups in Harohalli Hobli alone.

#### 6. AMICI Leprosy activities in North East states and Karnataka

AMICI continued to support Eight North Eastern States including Sikkim during the year 2017 in association with LEPRA. All the eight States are Low Endemic though few Districts are High Endemic. Therefore the Technical support is in Training, Reconstructive Surgery and Supervision monitoring have been extended.

**Supervision/monitoring:** AMICI continued to support the States in Supervision/monitoring. 6 (six) States have been visited (except Manipur & Tripura). Total 20 Districts, 5 Hospitals, 1 Medical College, 13 UHCs, 29 CHCs/PHCs, 4 S/c, 50 villages, 40 patients have been visited at their residence. Moreover, 5 suspects examined and 1 confirmed as leprosy. Validation of 6 cases done. 4 Leprosy colonies have been monitored and supervised as continuous rehabilitation of the Leprosy affected families.

**Leprosy Case Detection Campaign 2017**: AIFO Team also supported the State of Assam (5 districts), Mizoram (1 districts) and Nagaland (4 districts) in preparation, implementation of LCDC programme where 280 new cases in Assam and 3 cases detected in Mizoram. Nagaland did not conduct LCDC reportedly due to non-availability of fund.

**Reconstructive Surgery:** RCS in Borgang Catholic Hospital, Assam, with support of Surgeons by AMICI (provided by TLM) continues and 22 surgeries have been done out of which 14 (including 4 children) are Reconstructive surgeries and 8 are Ulcer development. The persons for RCS were screened at the Gauhati Medical College, Sonapur Secondary referral Centre, at Borgang Catholic Hospital and during field visit by AMICI Physiotherapist and Physio technician.



#### 6. AMICI Leprosy activities in North East states and Karnataka (Continued)

**Capacity building:** AMICI continued capacity building of NE States and 272 health personnel trained during the (S/c ANM=28, MOs=25, HWs & other staff=32, DLO=5, LCDC State level. Training=37, PEP=5). Moreover, 140nos. Faculty, PG students, UG students and Nurses of NEIGRIHMS, Shillong were sensitized.

**Screening:** Screening of 32 Street and school-drop out children and 13 relatives at Nongmynsong, Shillong City, Meghalaya, organized by AIFO in collaboration with District NLEP, East Khasi Hills and Reach Shillong Ministries (NGO). No leprosy case detected. Juice and snacks provided to all. Refreshment provided to all.

**Development of Referral System:** Through the initiative of AMICI Team, Ulcer Care Centre was established on the 15th June 2017 at District Hospital, Tinsukia with active involvement of Medical Superintendent, the Jt.DHS, Tinsukia, and MO DLC. 20nos. ulcer care conducted. The Centre will soon be upgraded to Secondary Referral Centre as approved in PIP 2017-18 and hopefully the number of persons utilizing the services will improve.



#### 6. AMICI Leprosy activities in North East states and Karnataka (Continued)

The First Secondary Referral Centre (SRC) which was set up and made function with effort from 29th April 2016 at the abandoned section of the Upgraded BHC, Sonapur, was shifted to the more hygienic and spacious location at District Hospital, Sonapur, through the initiative of AIFO Team and cooperation of Jt.DHS, Kamrup(M) and Medical Superintendent, Sonapur District Hospital. Total 77 OPD attendance in the SRC during 2017 and service provided ranging from Physiotherapy, Ulcer care (including MCR footwear distribution), complication management including POP and counseling. The Centre also is equipped with Slit Skin Smear and HB % testing kit. Manned by NMA (Govt.), Lab. Tech (Govt.), Physio Therapist (AMICI) and Consultant NLEP (AMICI) attending twice a week under overall supervision of Consultant NLEP (NE) the Centre continues to provide referral service. The OPD attendance is at present low as the surrounding districts are yet to refer cases to the Centre. However, effort will shortly be made to motivate the surrounding districts to refer cases to the Centre.

One successful Extended Referral Service was organized at Rajgarh, Dibrugarh District, by AMICI Team of Consultants, in collaboration with District NLEP, 28 patients attended (15UT, 08RFT, 04 suspected- 03 PB confirmed, 1 put under observation and 1 genl. health problem) and all were given respective referral service after each is seen by the Referral Service Team. (Detail Report attached). Moreover, AIFO also provide support to SLO, Assam, with NMS who assist in compilation and analysis of data.

**Summary:** 158 persons were taught Self-care, 283 persons were given physiotherapy, 72 aids & appliances provided, 84 MCR footwear distributed and 90 other DPMR services (ulcer care, RCS, development and follow up) provided.



#### 7. Community Based Inclusive Developmental Interventions

AMICI is implementing Community Based Inclusive developmental projects directly and also through partnership across India.

During the reporting year, we could able reach a total beneficiaries of 44304. though all these partners.

With support of all these partners, there are 1115 Self Help Groups have been promoted. All these groups have a total members of 15614 and they have received benefits. Among them 6864 persons with disabilities have been benefited from various SHG interventions.

There are 81 disabled people's organizations, with a total members of 6158 have received benefits from various CBID project activities.

#### 7. Community Based Inclusive Developmental Interventions (Continued)

#### **Project review:**

Amici technical team (Dr. Jose, Dr. Manimozhi and Dr. Jayanth) facilitated week long review exercise during the third week of Jan 2017 at AIFO office with reference to the MOU signed with project partners. A questionnaire was prepared to analyze projects situation in 2016 and to decide the future course of action for 2018. This was organized to strengthen AIFO's collective, cohesive and unified strategic efforts to carry out the future course of action for the under privileged persons. To analyze the questionnaires and to define the future actions, regional wise consultative/review meetings were facilitated in the 3rd week of January 2017

#### **Research and Publications:**

In the special issue of knowledge management for development (KM4D) journal, focused on disability. It includes a paper on persons with intellectual disabilities from AIFOs project in Mandya district and is co-authored by Head Programs AIFO India, Dr.Jayanth Kumar. He worked with Dr. Sunil AIFO Italy in providing, and analyzing the data for preparing the paper.

#### **CBID** and Leprosy Refresher workshop:

A 3 days intensive and residential workshop on CBR and leprosy was conducted between 6th to 8th of March 2017. A total of 13 Participants from 4 Andra and Telangana projects took part in the workshop. Dr. Jose, Dr. Manimozhi, Dr. Jayanth from AIFO and coordinators from Malavalli project facilitated different sessions on CBR and leprosy, action plan preparation, the new RPD act and other related topics.

#### In-service training for SRMAB, Malavalli staff:

On 17th and 18th February, 2017 two days refresher course and orientation on new disability law was conducted to SRMAB CBR Staff. Dr. Jayanth Kumar AMICI CBR Coordinator, Dr. Adharsh MBBS, DPM, District mental health programme, Ramnagar, Mr. Kalinayaka Leprosy control supervisor Ramnagar, Mr. Jospeh Director, CBR Programme, CBR Executive, CBR Coordinators and sector coordinators were the trainers for the programme.

#### CBR and CBID workshop in ORBIT Bidar:

AMICI and ORBIT jointly conducted 3 days workshop on different themes related to CBR, Leprosy, Disability, Human Rights, and mental health at ORBIT campus Humnabad from 13 to 15 July 2017. A total number of 31 people participated in the programme.

#### **Donation box scheme:**

The overall objective is to raise small local donation and to raise awareness about the organizational vision, mission and activities. This will ensure the involvement of local communities, make sure the support from donors and volunteers in order to attain organizational aims and objectives. So far, a total amount of RS 20, 000 has been collected from the donation box scheme.

#### **Community Based Inclusive Developmental Interventions (Continued)**

#### Workshop for NGOs on rights of persons with disabilities acts 2016:

One day workshop on Rights of persons with disability Act 2016 Government of India was facilitated by AIFO on 16th May 2017. Archbishop of Bangalore Bernard Moras was the Chief guest for the programme. It was Organised by Commission for the Differently Abled, Archdiocese of Bengaluru at Paalana Bhavana, Archbishop's House, Bangalore. Workshop Coordinated by Fr. George. Project/programme leaders, Managers, coordinators, middle level functionaries, trainers, trainees and similar level personnel in the developmental sector from 40-45 NGOs participated enhanced their knowledge on RPDA 2016. Dr. Jose, Fr. George, Dr. Jayanth facilitated various sessions with the support from the logistical coordinators team

#### AMICI and Basic Needs India (BNI) Collaboration:

BNI and AIFO discussed the needs of mental health issues and joint action plan in detailed way. AMICI and BNI agreed to work together on developing joint proposals to submit with CSR and International AID agencies to work on mental health issue in the north eastern states and Karnataka in South India.

#### in-service staff as refresher training workshop on CBR and CBID:

On 16th, 17th and 18th November 2017, three days refresher training workshop on CBR and CBID was conducted at TRDC- Jakkasandra. 21 CBR Workers already working in SRMAB CBR Project Malavalli and Denkanikote attended the programme. Refresher training was conducted to understand difference between CBR and CBID, orientation to new disability act, The Rights of Persons with Disabilities Act 2016 and screening disabilities along with activity planning, executing and reporting.


